Public comments: Jessy Mattocks was in attendance. Jessy Mattocks stated that most everyone knows him, he has rented the garage across the street for 27 years. Jessy Mattocks stated that starting Sunday 04/13/2025, he called Chief Jorgensen on the phone and left a message to be called back.
