Discussion and possibly act to amend proposed budget for 2026. The Village of Centuria approved payment support to the BLCPD for 2026 at \$134,332.00. This is down from the BLCPD budget proposal request of \$140,538.00. **Motion by Chuck Ellsworth to receive the final budget numbers for the Village of Balsam Lake from CLA to reflect assigned % shares equitably during the Village of Balsam Lakes preliminary budget hearing on October 22nd, 2025. (1) Budget, Finance, and Ownership of Assets could be reviewed by the commissioners.
