Commissioners' terms were reviewed. It was noted that the term for James Duncan Jr. ends in April 2027 and the term for Corby Stark ends in April 2028. It was noted an agenda item should be placed on the next Village of Balsam Lakes Board Meeting to discuss if the Village of Balsam Lake wishes to keep both individuals on the Commission or if the Board would like to appoint new members to finish the terms. It was noted by both James Duncan Jr. and Corby Stark that they would be willing to finish their terms.

Police Chief report was given by Chief Jorgensen. Since the first of the year there have been 103 calls for service. It was noted that the BLCPD has an extra camera they would be willing to install at the Clerks Office window in Balsam Lake. It was recommended that installation of a camera be added to the next Village of Balsam Lakes Board meeting agenda.
